 pounds until the whole of their said legacies with interest for the same after the rate
 of five pounds per Cent per annum shall be wholly paid and satisfied and it is also
 my will that each of them my said younger sons William Henry and Alfred shall be
 paid the sum of one thousand five hundred pounds part of their said portions within
 and as they shall severally attain the age of twenty one years and afterwards the yearly
 sum of one thousand pounds until the whole of their said portions together with
 interest for the same after rate of five pounds per Cent per annum shall be fully
 paid and satisfied and it is likewise my will that my said sons John and Samuel
 and my said daughters Ann and Francis shall be paid the yearly sum of one thousand
 pounds on account of their respective portions therein before given so that until the
 whole thereof together with interest for the same to be computed from the end of
 one year next after my decease after the rate of five pounds per Cent per annum shall be
 fully paid and satisfied and I appoint my said son John De Witt and Samuel
 De Witt the younger my said son in law Stephen Ogley and my said daughter
 Sarah De Witt Executors and Administrators of this my will and it is my will that if any
 dispute or disagreement shall arise relating to the said Executors or the Affairs
 thereof that the same may be adjudged by my said son calling in one friend and my
 son in law and daughter Sarah calling in one friend to hear and determine the same
 and it is my will that none of them my said Executors and Administrators shall be answerable
 or accountable for the acts or defaults of the others or any of them but
 each of them for their own acts or defaults only and that it shall be
 lawful for them my said Executors and Administrators by and out of the last Wills
 and Testaments shall come to their hands to deliver and deliver all their reasonable costs
 charges and Expences in or about the execution of the Wills of this my will and
 I appoint my said wife Francis De Witt Sole Guardian of all my younger Children
 during her widowhood and after her death or second Marriage I appoint my said
 Executors and the Survivors of them Guardians of my said Children during their
